## 1. Details Of Posting Crimes of Females to CAF

---

Today woman are committing crimes with complete impunity in the western world. The criminals in the judiciary will not hold women "equal before the law". Therefore there is a need to have a global registry where details of crimes by women can be placed so that it is searchable to the public so that the public can sanction such women. It is also important for men to protect themselves from such women.

This is proposed to be implemented by Crimes Against Fathers and our Global Portal infrastructure.

## 2. Service Delivery Procedure

---

The Service Delivery Procedure for the Posting of Crimes by Females to CAF will be as follows:

1. The Client is required to make oath that all materials provided to CAF is true and correct and the product of first hand knowledge. Client is required to make oath that all information is provided under oath and penalty of perjury. The client will be presumed to have made this oath when he applies his signature to the signature page on the form below.

2. The Client is to pay the amount of EUR10 or EUR50 to the paypal account as follows:

Client must mention the email address provided above in the payment details for the payment so that the link between the payment and the forms sent to CAF can be easily made.

3. The Client then completes the associated form to provide identification in the event a counter claim is brought to CAF by the female in question.

The form is scanned and emailed to [DenounceCriminalWomen@crimesagainstfathers.com](mailto:DenounceCriminalWomen@crimesagainstfathers.com) or faxed to +61-280790691.

4. The Client then completes the exact text he wants loaded up the CAF site. Any images that are to be loaded are to be provided as attachments to the email that will be sent to CAF.

The email to send the exact text to be posted, plus images is as follows:

Note: The Client may send the form and the email/images denouncing the female in one email.

5. The Service Provider will call the telephone number provided to ensure that the Service Provider speaks to the man who claims to have sent the form to reduce the possibility of women making false statements masquerading as men. Where possible a skype conference call will be performed so that the photo of the man on the identification documents can be matched to the mans face making the claim.
6. The Service Provider will allocated a case number and post the details to the relevant CAF portal.
7. The Service Provider will email the Client to confirm the posting was made.
8. The Client will check the entry and confirm that he is satisfied with the service.

### 3. Deliverables

---

The following deliverables will be produced:

1. The relevant paperwork will be printed and filed in an undisclosed location.
2. The posting to CAF will be made with the exact text provided by the client along with images provided by the client.

---

### 4. Responsibilities of Service Provider

---

The Service Provider undertakes the following responsibilities:

1. The Service Provider will review the paperwork to determine the plausibility of the claim being made. This is to protect from obvious false allegations from women.
2. The Service Provider will call the Client via skype on the telephone number provided to make sure that there is a man on the other end of the phone who knows the details of the claim that is being made. This is to protect from false allegations from women.
3. The Service Provider will exercise all due care and skill to protect against false allegations being made on CAF by women against other women.
4. The Service Provider will post those appends to CAF that look real and reasonable and have been confirmed by voice to the man who claims to be involved.
5. The Service Provider will email the Client one week before the anniversary of the posting for annual subscriptions so that the Client can enjoy un-interrupted service on the posting that has been made.
6. Where the subscription is not renewed the Service Provider will take down the posting one week after the expiration of the subscription. To re-renew the subscription after the removal of the subscription will incur a fee of EUR10 to discourage creating work for CAF staff by failure to renew and then re-renewing.

## 5. Responsibilities of Client

---

The Client undertakes the following responsibilities:

1. The Client will make the agreed payment prior to the start of work unless specifically agreed in writing with the Service Provider at the risk of the Service Provider.
2. The Client warrants that he is not an agent of any government or any secret society that is attempting to subvert the business processes of the Mens Business Association.

By signing this contract the Client is warranting such under oath, penalty of perjury and full commercial liability.

3. The Client warrants that all information provided to the Service Provider is true to the best of his knowledge and reasonable ability to determine.
4. The Client undertakes to answer any and all fair and reasonable questions in a reasonable time frame so as to enable the Service Provider to complete the preparation of the posting.
5. The Client undertakes responsibility for all information supplied and holds harmless the owners of Crimes Against Fathers for any false and/or misleading information that is posted.
6. The Client undertakes that he is, at all times, responsible for any and all outcomes from performing the Posting of Crimes of Females to Crimes Against Fathers.

## 6. Jurisdiction of Agreement

---

This Agreement is the property of the Mens Business Association and remains the property of the Mens Business Association in perpetuity.

This Agreement between the Client and the Service Provider is executed in the sole jurisdiction of the Mens Business Association.

By signing this Agreement the Client and the Service Provider indicate their agreement that any dispute that arises from the performance of this Agreement will be resolved by MBA Law Services which may include:

- MBA Adjudication Services  
or
- MBA Criminal Prosecution Services.

## 7. Terms and Conditions of Service

---

The Service Provider provides these services under the following Terms and Conditions:

1. The Service Provider is held harmless for any outcomes or any results created by the use of these contracts by the Client.
2. The Service Provider warrants that he will exercise all due care and provide all due advice to the Client so as to explain the use of these documents.
3. The Service Provider assumes that all information provided by the Client is true and correct to the best of the Clients knowledge.
4. The Service Provide assumes that the Client is honest in his business dealings and does not warrant the Posting of Crimes of Females to Crimes Against Fathers service to be effective should the Client have provided incorrect information.
5. The Service Provider is not bound to begin work until payment has been received.

## 8. Termination Conditions

---

This contract may be terminated with immediate effect by the Service Provider under the following conditions:

1. The Client is proven to be the agent of a government or the agent of a secret society that is attempting to subvert the business processes of the Mens Business Association.
2. The Client is proven to have provided information to the Service Provider that he knew to be false at the time it was provided.
3. The Client provides a written, scanned, and signed instruction to terminate the service.

This contract may be terminated with immediate effect by the Client under the following conditions:

1. The Client has issued a claim to MBA Law Services that the Service Provider has either been derelict in the performance of the contract (MBA Adjudication Services) or committed a crime during the performance of the contract (MBA Criminal Prosecution Services).
2. The Client no longer wishes to perform the service. No refund of unperformed work is mandatory. The Service Provider may refund fees for unperformed work at his sole discretion.

## 9. Completion Conditions

---

This Agreement will be considered complete under the following conditions:

1. The Service Provider has posted the email provided by the Client and any pictures attached to the relevant CAF Portal.
2. The Service Provider has sent an email to the Client confirming the link.
3. The Client has sent an email to the Service Provider confirming the link and correctness of information posted.

## 10. Signature Page

By Applying Signatures the Client and the Service Provider enter into this Agreement.

- Both parties warrant that they are of sound mind and good health, are over the age of 18, and are able to present themselves.
- Both parties warrant that they are not subject to any Agreement that would negate their lawful right to sign and execute this Agreement.
