The following instructions apply to this document.

Copy the word file to a file that is named F001 – You calling Vnn.nn.doc

1. Make the changes noted in the document to include where you want your mail sent, your email, your fax etc.
2. When you are finished print the Original Document.
3. Have three witnesses witness your signature on each page in RED INK ONLY.
4. Sign and date the bottom of each page with “Original Document – you signature - date”
5. If you want to be responsible for this document then retain this original.
6. When making copies then write in the left hand margin
“Certified copy – your signature - date” in RED INK ONLY.

7. Send the certified copy to the MBA for consideration. Send your CV and related hard copy documentation of your qualifications and why you want to be an MBA. Please include two references from men of good standing in your community. Explain who they are and provide contact details for your references.

We will contact you if we need more information.

8. If you wish MBA to store your original document then print off the appropriate form and send the package to us for storage. We can then create certified copies of documents at your request and we can send the scan or hard copy anywhere in the world.

I, commonly addressed by the calling of First-Second: Family©, hereinafter the “Principal”, in my correct public capacity as beneficiary to the Original Jurisdiction, being of majority in age, competent to testify, a self realized and free sentient man, my yes be yes, my no be no, do state that the truths, facts and oaths herein are of first hand personal knowledge, true, correct, complete, certain and not misleading, so help me God.

This Notice is addressed to Respondent and all the men and women of Gods creation commonly known as Planet Earth.

**BONDED AFFIDAVIT TO JOIN
THE MENS BUSINESS ASSOCIATION**

1. Principal is of legal age and competent to testify.
2. Principal is of legal age and competent to make oath.
3. Principal has first hand knowledge of the facts stated herein.
4. Principal has not seen or been presented with any material fact or evidence that shows that Principal does not have lawful right to make the oaths of this affidavit.
5. Principal makes oath that he wishes to join the Mens Business Association as an Associate.
6. Principal makes oath that he is not aware of any reason why he would be denied the benefit of being made an associate of the Mens Business Association.
7. Principal makes oath that he has never been found guilty by a jury of his peers of committing fraud in contracts or of causing injury, harm or loss to any other man.
8. Principal makes oath that he has never attempted to gain business advantage by lying to clients or customers or colleagues and has at no time refused to make remedy for any transgression of trust or faith placed in him by a business colleague.
9. Principal makes oath that he has read and comprehends the following documents.
 - a. The Mens Business Association Founding Principals version nn.nn.
 - b. The Mens Business Association Law Procedure Manual version nn.nn.

10. Principal makes oath that he will always act honestly, with honour and with integrity in all business dealings with all other people.
 11. Principal makes oath that he will bring any allegation and evidence of a crime of any other associate to the notice of the relevant associate or to the personal notice of Joshua-Brandon: Boehm© until Peters successor is named.
 12. Principal makes oath that he will observe the two foundation laws of the Association:
 - a. Always be honest in contracts. Never use fraud in contracts.
 - b. Never cause injury harm or loss to another human being who is afforded the protection of the law by way of claiming the protection of the law for the agreement to obey those same laws of which the human being claims protection.
 13. Principal makes oath that should he unintentionally or accidentally cause injury harm or loss to another human being who has claimed the protection of the law he will make remedy that is reasonable and within the standards of the community in which he chooses to live.
 14. Principal makes oath that should he stand accused of a crime that he denies, that being causing injury harm or loss to any other human being or fraud in contracts, by way of a sworn affidavit and accompanying evidence, that he agrees to the lawful authority of a lawfully constituted court of fellow associates with a lawfully constituted jury of 12 associates sworn to judge his case justly and fairly on a lawfully equal basis to any other human being presented to such a jury.

The number of associates on the jury may be less than 12 should both parties agree to a lower number so as to reduce the costs of the Jury Trial.
 15. Principal makes oath that should he be found guilty of the crime of which he is accused by a jury of his peers, beyond any reasonable doubt, then he will make the Remedy Instruction that is issued by the unanimous decision of the jury of his peers.
 16. Principal makes oath that he will undertake this Remedy Instruction even if Principal is aware that the verdict is a false guilty.
 17. Principal makes oath that he understands that he will retain the right to retrial for a false guilty verdict for the remainder of his life.
 18. Principal makes oath that he will stand under the lawful axioms:

“All men and women are equal before the law”
“All men and women are innocent until proven guilty”
“Burden of proof is with the plaintiff”
 19. Principal makes oath that he will serve on the juries of the Mens Business Association as a lawful obligation as and when called to perform this service and circumstances allow.
 20. Principal makes oath that he will accept the compensation of one ounce of silver, or currency equivalent, per hour of service on the juries of the Mens Business Association.
 21. Principal makes oath that he agrees to the Mens Business Association Adjudication Services in the event that a human being with whom he has entered into a contract claims that he has not lived up to the terms of the contract in an honest and honourable way.

22. Principal makes oath that he agrees to bear the cost of the Mens Business Association Adjudication Services until the point where the Associate who performs the Adjudication Services issues a decision that the claim was frivolous and without basis.

At that point in time the Associate may lawfully Bill the customer/client for the cost of the Adjudication Services and his own time on a basis that the Bill is reasonable, reflects actual costs, and is signed off by the Adjudicator as fair and reasonable.

23. Principal makes oath that he will, at all times, be held lawfully responsible for any business work signed on a Mens Business Association contract that he passes to a woman.
24. Principal makes oath that he will, at all times, openly declare any work given to him by customers or clients that will be performed by a woman who is working under his direct liability and direction.
25. Principal makes oath that he is aware that the Mens Business Association Law Services does not recognise the signature of a woman as lawfully binding and that no contract signed by a woman can be brought to the Mens Business Association Law Service or Mens Business Association Adjudication Services.

Principal makes oath that he bonds these oaths with the amount of XXXX Troy Ounces of 99.99% pure gold. This bond amount to be forfeit to any man who gains a guilty verdict by a jury of the Mens Business Association Law Services that any of these oaths were broken.

This amount is the declaration of what the Principals word is 'worth'.
