
Instruction Page

The following instructions apply to this document.

Copy the word file to a file that is named F002 – You calling Vnn.nn.doc

1. Make the changes noted in the document to include where you want your mail sent, your email, your fax etc.
2. When you are finished print the Original Document.
3. Have three witnesses witness your signature on each page in RED INK ONLY.
4. Sign and date the bottom of each page with “Original Document – you signature - date”
5. If you want to be responsible for this document then retain this original.
6. When making copies then write in the left hand margin
“Certified copy – your signature - date” in RED INK ONLY.
7. Send the certified copy to the MBA for consideration. Send your CV and related hard copy documentation of your qualifications and why you want to be a Peace Officer. Please include two references from men of good standing in your community. Explain who they are and provide contact details for your references.

We will contact you if we need more information.

8. If you wish to be a anonymous Peace Officer then clearly mark the outside of your package as “Personal and Confidential. For Addressee Only.” Address it to Joshua-Brandon: Boehm©. In this way staff at the MBA will know not to open the package.

I will receive all such packages unopened. You have my word that I will keep all such information secure and they key to that cabinet will only pass to my successor when he is named.

9. If you wish MBA to store your original document then print off the appropriate form and send the package to us for storage. We can then create certified copies of documents at your request and we can send the scan or hard copy anywhere in the world.

**BONDED AFFIDAVIT TO BE
A PEACE OFFICER**

1. Principal is of legal age and competent to testify.
2. Principal is of legal age and competent to make oath.
3. Principal has first hand knowledge of the facts stated herein.
4. Principal makes oath that he wishes to be a Mens Business Association Peace Officer.
5. Principal has not seen or been presented with any material fact or evidence that shows that Principal may not be a Mens Business Association Peace Officer.
6. Principal makes oath that he has never been found guilty by a jury of his peers of committing fraud in contracts or of causing injury, harm or loss to any other man.
7. Principal makes oath that he has never attempted to gain business advantage by lying to clients or customers or colleagues and has at no time refused to make remedy for any transgression of trust or faith placed in him by a business colleague.
8. Principal makes oath that he is not a member of any secret society, in particular he is not a mason or connected with any Masonic activity.

9. Principal makes oath that on acceptance to becoming a Peace Officer he will take the following oath.

"I swear that when acting as a Peace Officer I will discharge my duties as a Peace Officer for the Protection and Benefit of Associates and those who hire me under contract.

I swear that I will carry out instructions from the unanimous decision of a jury of a properly convened court of the Mens Business Association to the best of my ability.

I swear I am, at all times, responsible to ensure that all actions I undertake, having been asked to undertake such actions, are lawful actions.

I sweat that should I be asked to undertake an unlawful action by an associate that I will report that request to perform an unlawful action directly and immediately to Joschua-Brandon: Boehm© or his successor. "

12. Principal makes oath that he has never and will never swear allegiance to any man or any organisation over and above his oath to uphold the law of the Mens Business Association.

Principal makes oath that he bonds these oaths with the amount of XXXX Troy Ounces of 99.99% pure gold. This bond amount to be forfeit to any man who gains a guilty verdict by a jury of the Mens Business Association Law Services that any of these oaths were broken.

This amount is the declaration of what the Principals word is 'worth'.
