1.3. Tasks Performed

The following tasks have been completed in order to develop the Founding Principles Document.

1. I spent the best part of 3.5 years, USD500,000 and 3,500 hours learning just how criminal the guvments of the world are.
2. I determined to re-introduce the rule of law into Australia and Ireland.
3. By doing so I learned about the legal system and the systems LAW that had been used in the world in times gone past.
4. Having gotten the ball rolling for re-introducing the rule of law to Ireland and Australia it occurred to me that there needs to be a way of doing business which excludes the “good help” of the “guvment”.
5. After much thinking about this I determined to start Mens Business Association as the vehicle for a global association to enable men to do business without being subject to the jurisdiction of any government.

6. I am in the process of migrating and customising the standard documents for common law across to the Mens Business Association. These will be released in due course.

1.4. *Scope*

2. THE STATE OF THE WORLD TODAY

The problem that then remains is how to do business and earn a living when the guvments, legislature, courts, lawyers, cops and co are **ALL CRIMINALS?**

The answer to that is to form an association that operates **OUTSIDE** the jurisdiction of these corporate entities. In doing so the members of the association will need services provided to them that are only exclusively available from the corporations today. The three main areas of need are:

1. A system of law that is fair, just, open, transparent, reliable, very high quality and trustworthy.
2. A system of contracts by which association members can contract with other members or with members of the general population.

It is also necessary for the member to be able to contact with companies where the owners of those companies choose to remain in the jurisdiction of the criminals guvments.

3. A banking system that allows transactions internationally that is reliable and not open to fraud or theft.
4. Passports that are observed by the criminals in the various border patrols around the world.

With these four things it will be possible for Associates to do business with other Associates and other companies all across the world.

So. The need for an association like "Mens Business Association" is to enable honest men of honour and integrity to leave the jurisdiction of the criminal guvments and move across to a more honest and open system should they so choose.

My own view is that I just spent about 3,500 hours gaining a much better understanding of how the world works and that by leveraging that time and effort I can turn it into a business venture for my future income.

In addition to my normal business I will run the MBA as a side business because I will need it for myself and my own business.

5. THE VISION FOR THE ASSOCIATION.

The vision for the association is this.

“A global association of honest men of honour and integrity who collaborate and co-operate to manage some or all of their various business interests outside the jurisdiction of any national government.”

This just about says it all. An associate can run portions of this business inside the jurisdiction of the national government if needs be. After all, in the early days most customers will be reluctant to buy services that do not look like everything else they know. All they know is contracts that are done by the lawyers etc. We can be sure the lawyers and the guvments will all deny that anyone can operate outside their jurisdiction.

What we will need to educate men who run businesses with is this. We will need to educate them that the persons described in their contracts are NOT people. They are juristic persons. And therefore when they go to court no human being is obliged to pay any compensation. Once all property have been moved from the juristic person to the human being the juristic person no longer has any assets to seize, including the body of the human being.

We will have to educate business people that the legal system is deficient in this area and that they are better off to move across to our system of law which operates at the level of the human being and NOT the juristic person.

If we can win some cases on this basis then we will be able to give a little wake up call to all those people who are currently running businesses.

The vision for the association is to be global with a representative in the capital city of each country as the first major goal. It might take a while for the smaller countries. I see this as quite achievable.

6. THE FOUNDING PRINCIPALS.

These are really simple.

The Mens Business Association is founded on these principles.

1. Honesty, Honour and Integrity.
2. Men doing their best for their customers and clients.
3. Men let their customers and clients decide if they want to buy products and services from honest men of honour and integrity.
4. Never use fraud in your contracts.
5. Never cause injury, harm or loss intentionally.
6. Should a man cause injury, harm or loss he volunteers to remedy this situation without the need to be forced to do it.
7. Should he be unwilling to make remedy, or denies the allegation, then he will stand trial before a jury of his peers.

It really is that simple. This is all the “law” anyone needs to know.

7. SERVICES IN THE NEAR TERM.

The Mens Business Association will offer a wide range of services via the members of the association.

The members may offer whatever services they choose to offer so long as they are not causing injury harm or loss to anyone.

I will not allow my name to be attached to products or services that cause injury, harm or loss to people. The Association is intended for honest men of honour and integrity to be able to offer their products and services in an alternative system of law to the criminal legal system and government system.

I will give preference to applicants who are proposing to offer products and services that are of high quality and legitimate value to their clients and customers. Yes. I will check out men who apply to be an associate and I will check out their products and services. I am the founder of this association. I intend to make the brand synonymous with being trust-WORTHY in business.

My clients hire me and pay me, and my colleagues pass my name along as a reference because they TRUST ME to do the right thing in ALL cases. My clients and colleagues know that whatever happens, I WILL DO MY BEST. And as many of them say "Your best is pretty good".

So if you are considering becoming an associate and you know yourself to be dis-honest or you know yourself to lack honour and integrity? Please save all our time and do not apply to join our Association. You will be found out eventually and you will be heavily penalised for lying to us in the first place.

We only want honest men in our association.

7.1. Law Services

The first and most important service that is being constructed is the Mens Business Association Law Service. There is no point creating an Association to operate outside the jurisdiction of the government if there is not a system of law in place that the members and the clients/customers can rely on.

The system of law is based on common law as is discussed in the Christian Bible but also turns out to have been used in many cultures in many countries over many thousands of years.

We are going to use the latest version of this ancient system of law and we are going to base it on the Jury Trial. All members of the Association will agree to be bound by the laws of the Association. These laws are this.

1. Be honest in your contracts.
Dishonesty in contracts will be considered the crime of fraud. An associate who commits fraud will be required to make remedy to the value of the fraud committed.
2. Do not cause injury harm or loss to any other human being.
To cause injury harm or loss to any other human being will be considered a crime. The crime of causing injury, harm, or loss will be remedied by fixing the damage or paying an amount that is satisfactory to the victim of the crime. If the victim of the crime is being unreasonable it will be the amount instructed by the jury.

The remedy process for any alleged crime will be by sworn affidavits followed by a Jury Trial if the sworn Affidavit process does not produce a result. There will be a procedure manual written for the remedy process.

There will be an MBA Court. All members of the MBA will have an OBLIGATION to serve as jurors on the court for the fee of one ounce of silver per hour of service. All Affidavits and all contracts signed by the MBA will be subject to the jurisdiction of the MBA Court and will be to the effect of the human beings involved and NOT the corporate fictions of the NAME. The entire process is going to be performed in the PRIVATE and not in the Uniform Commercial Code world.

Contracts with CLIENTS might be between a company that is created for the purposes of interfacing with the Uniform Commercial Code world but the clients will be offered MBA Contracts with MBA Adjudication Services, MBA Law Services and the MBA Court for the adjudication of disputes or crimes.

For accusation of crime where the accused denies the crime and the accuser is adamant that he has enough evidence to convince 12 associates (or however many the two parties agree on to adjudicate) of the guilt of the accused, the accuser may ask for a criminal trial to take place and submit his evidence to the jury.

The jury is the FINAL arbiter of the trial process and will collectively decide guilt or innocence. Decisions must be unanimous. If the accused is found guilty then the jury issues a Remedy Instruction. If the guilty party does not make remedy then he will be outlawed from the Association and all property will be seized according to his oath of joining the Association. On joining the Association members must pledge ALL property as their collateral for refusing to make remedy for a crime of which they are found guilty.

7.2. *Negotiating with Governments*

One of the obvious problems with setting up the MBA is that the criminal governments are not going to be very happy with us at all. Governments are all about control and making sure THEY control people. MBAs are going to rescind their consent to be governed and will operate in part or totally OUTSIDE the control of governments and their criminal legislation.

It is to be expected that government agents will make trouble for associates out of ignorance or by being plain malicious and jealous.

It is important that the MBA establishes contracts with governments such that those governments have been well noticed that the MBA is coming into existence and that members enjoy the protection of the Law via MBA Law Services and Peace Officers.

It is important that when a government agent causes an MBA trouble that the head of the corporate government be held DIRECTLY ACCOUNTABLE. This is the same structure where directors of companies are held accountable for the actions of their staff where they have failed to provide clear guidelines to their staff as to what they can and can not do.

Over recent years I have been dealing with the so called "world leaders" of the UK, Germany, Australia and Ireland. These people have been singularly unresponsive and almost ALWAYS choose to go into lawful dishonour.

The MBA will provide Law Services and Peace Officer Services to members where their rights are violated and crimes are committed against them by criminal government agents.

7.3. Contract Services and Associated Adjudication

Members will require sets of contracts that can be used to exchange services in a reliable and protected by the law of the Association method. Therefore the Association will build up, over time, a set of template contracts that will be available for members to use in their businesses.

These contracts will be simple and straightforward. The masters will exist in English and members may choose to translate the masters to any other languages they wish. The primary language of the association will be English. This is only because that is my native language.

There will also be a contract verification service similar to the services of a Notary Public. This is in the case where a contract is signed by two parties and both parties wish that they each have a notarised copy of the contract.

There will be a contract storage service and verification against that stored contract service. The idea of this service is that a member can have a contract or an affidavit signed and wish it stored safely and securely for a long period of time. This will be stored in a safe environment at an MBA site as well as being scanned and the scan and copy certified to be the same by the MBA. Then, should someone wish to enquire as to what is on the document it can be retrieved from the scan and what is on the document can be presented to the inquirer.

This service will also serve well for such things as the affidavits by women for lawful equality. As more and more women complete said affidavit then there will be a need to store these. And more and more men will want to know what is said on them. It is proposed that a register be created where such affidavits can be stored and then can be retrieved by MBA staff and sent to the inquiring person.

The MBA will have certified the affidavit and the affidavit will be considered signed under oath. This will stop the practice of women creating such affidavits fraudulently. Those who register affidavits with the MBA will be required to agree to MBA Law Services as the adjudication process. They will be required to bond the affidavit with an amount of money that will be taken from them if they are found to break their bonded affidavit.

It is expected that there will be times when there is a contract dispute and the parties are not claiming that a crime was committed, merely that there is a dispute in the contract and the work delivered.

The MBA will provide the service of Contract Adjudication. This is a service where an MBA, and in the early days it will be myself, is provided with all inputs from each party along with affidavits signed under oath and the Adjudicator determines the outcome of the dispute. Both parties will agree to the Adjudication Process. In the end, all final Adjudication will rest with myself as I am the founder. I claim the right to adjudicate on the basis that the value of the brand is linked to the adjudication.

I will delegate Adjudication Processes to those men who have proven their honesty over the longest period to lighten that load somewhat.

7.4. Banking And “Money” Services

The MBA will develop the ability to perform banking transactions internationally. This is most likely to be via agreements with existing banks but there are some interesting developments around the world in barter/trade systems where people in an association barter/trade “units” and these units are seen as the “money” of the association. There are also groups starting up the printing of notes which are being used as money in small local economies.

So the whole advent of localised money or some form of “points” is a very interesting event.

No matter what happens. Over time the MBA will develop Banking Services that interface with the existing banking system so that “currency” can be exchanged from inside our banking system to the existing banking system.

It is also likely that the MBA will recognise silver and gold as “money” and that silver and gold coins will be used as “money”.

It has already been determined that members who serve on juries or serve as Peace Officers of the Court will be paid one ounce of silver per hour of service. These are rates of payment that are consistent with the value that is being produced for those who need to avail of these services. For services that are “mandatory” towards members in their process of gaining remedy for crimes the pricing will be set my me for all members, myself included. There will not be any profiteering from MBA Law Services. We have seen what profiteering got us with lawyers and “legal services”.

In the end, there will be a way to exchange “money” for products and services globally.

It is also expected there will be some agreement or mechanism to use credit cards such as VISA over the longer term. This will allow members to participate more easily in the highly credit card or electronic card system that the guvments have built to try and control us.

7.5. Passport Services

I have been working on getting my World Passport working for the last two years or so. I am collaborating with the good people over at the World Service Authority on getting this done.

The World Passport is quite a good looking passport and it is machine readable. Most importantly, it does not have a chip in it.

The MBA will accept requests for passports from Associates and organise those passports. We will merely be a clearing house for those requests making sure that the passport is first delivered to us. We will keep scans and details on file for all passports for all members.

We will then provide the service of dealing with any national governments should any of our associates be stopped by "border patrol" for any country for which the MBA has developed a treaty for the safe passage of our members. The service will need to be paid for by the associate on a time and materials basis. There will be no "free" services that consume the time of a man in the MBA. If it is worth doing? It is worth paying the man to do it. If a man is not willing to pay for another man to do something for him? Then he should do it himself or it should remain undone.

There will be an amount of "give and take" between associates. But there can be no free services from the MBA itself. If we did that, experience shows, we would be inundated with requests for "free stuff" and the business would collapse under the weight of men refusing to pay their way.

It is expected that the MBA will be able to negotiate with national governments that all members will be free to travel to any country for business purposes without the need for the machinations of their government machinery. This might take some time.

7.6. Identity Document Services

Many governments have the delusion that they can demand identification documents of a human being at any point in time. To placate these agents who are most insistent it is proposed that the identification documents of the World Service Authority will be used.

7.7. Peace Officer Services

One of the biggest issues with the governments is that they pretend they have a monopoly on the licensing of "Policy Enforcement Officers" who are also known as "Police". They seem to miss the fact that we can create our own staff of Peace Officers.

The purpose of a Peace Officer is to "maintain the peace". The Peace is broken when one human being commits what is considered to be a crime against another human being. The Peace Officers will offer services to BOTH members of the MBA as well as CLIENTS of the MBA.

Further. Peace Officers will be able to offer their services to the broader public as an MBA Peace Officer for whatever fee the market will bear. It is anticipated that there is a demand for Peace Officers in the general public as well as in the MBA.

This means that if an MBA has a crime committed against him that other associates of the MBA are **OBLIGED** to create the environment by which that crime can be remedied. It is an **OBLIGATION** on joining the MBA and it will be clearly explained in the Affidavit of Application.

Further, if a CLIENT of an MBA makes claim of a crime in relation to the contract being performed by the MBA then the associates of the MBA are **OBLIGED** to provide Law Services to the CLIENT to properly determine the truth of the matter.

This is where the Peace Officers come in.

The services that will be provided by Peace Officers are as follows:

1. Document Serving Services.
Service of documents onto those to whom they are addressed and certification of those services to the MBA Court.
2. Investigating Crimes and Evidence Gathering Services.
Investigation of alleged crimes in the pursuit of gathering evidence that can be presented to the MBA Court. In this role the Peace Officer will act very much as a Private Investigator. The MBA or the Client may not be able to gather said evidence themselves for whatever reason. The most obvious one of which is that the alleged criminal knows the face of the accuser.

In order to gather evidence of criminal activity the MBA or the Client is very likely required to engage a third party to gather said evidence. Naturally, such work will be required to be compensated at a reasonable rate to the Peace Officer.

3. Protection Services.
The Peace Officer may provide protection services for associates who seek such services. For example, security guards for corporate properties, transport of valuable goods, or even so simple as explaining to people who refuse to make remedy for crimes that after the court case it is HE who will come to seize property to it is better to settle matters peacefully up front. A little bit of "explaining" up front could save a lot of trouble further down the line.
4. Secure Transfer Services.
It is anticipated that MBA associates will, from time to time, need the secure transfer of valuable goods from one place to another. The thing I expect this will mostly be is gold or silver or sums of "currency".

It is expected that the MBA will create a relationship with some swiss banks and that the MBA will offer the services of Safety Deposit Boxes in these banks. Should the MBA wish to have valuables transferred to the safety deposit box in absolute secrecy then a Peace Officer may offer his services to perform this transfer.

5. Carriage of Valuable Items Services.
In some cases people need valuable items carried from one place to another, say to a relative, with absolute security. Such things as family heir looms come to mind. Peace Officers may offer their services for the transfer of such valuables.

6. Property Seizure Services.

The MBA Court will be run under common law and will have the authority to issue Writs of Execution for Property Seizure. A party found guilty of a crime, particularly an MBA, will have a Remedy Instruction issued by the MBA Jury in a properly convened MBA Court.

If the guilty party is not willing to make the Remedy that has been Instructed then the MBA or Client can pay the Peace Officer to make the Property Seizure that has been Instructed by the Jury.

The jury will have also issued an Outlawry Writ against the guilty party and the Peace Officer can be paid to deliver this Writ to government officials so as to turn off all government services to the Outlaw.

In particular the Peace Officer can deliver the Outlawry Writ to the local Policy Enforcement Officers to inform them that they can no longer provide protection services to the outlaw and that if they do then they too might find themselves facing an MBA Court as well as facing a Writ of Execution and an Outlawry Writ.

It will be interesting to see what the local cops make of our Peace Officers, who are going to be most likely ex armed services in the main, walking into their offices fully armed and saying "stay out of this one". THAT will be fun.

The common law of "aiding and abetting a known outlaw is a crime" will be observed by the MBA courts.

It should be taken as assumed that Peace Officers can choose to be armed and choose to use whatever weapons or force they deem appropriate to seize the property of a guilty party.

Further. A Peace Officer may ply his trade anywhere in the world for any MBA or any client who wishes to pay him his asking price.

It is expected that Peace Officers will put in place computer systems that will assist in them performing their services. Indeed, it is likely that these computer systems will be put in on top of the existing MBA systems.

All Peace Officers will be vetted personally by myself. They will have to make application directly to me until further notice. They will have to create affidavits and testimony to me personally and take the oath of a Peace Officer to me personally. Only then will they be allowed to advertise their services as a Peace Officer of the Mens Business Association.

Naturally any such Peace Officer who is found guilty of a crime by a jury of MBAs will have ALL property they own taken from them. There will be zero tolerance of criminal acts by those who have sworn to be Peace Officers or other associates in the MBA Courts or Law Services. This will be made clear to ALL associates who apply to become an MBA Peace Officer.

In all cases Peace Officers will be paid on a time and materials basis by associates or non-associates. There is no plan and no proposal to pay full time salaries to Peace Officers that can simply be drawn on at a phone call as is the current situation with Policy Enforcement Officers.

Policy Enforcement Officers are paid for by the mandatory taxation of all members of a community.

The MBA will have NO mandatory taxation. Indeed, NO mandatory anything. All actions must be paid for on a "pay per use" or "pay as you go" system. This will be handled via the MBA Banking system. All members will be offered a Bank Account and transfers between members for "credits" or "money" will be achieved by web based applications.

Should a man wish to become a Peace Officer but wish to remain totally anonymous I will be the SOLE holder of the relationship between the man and the Peace Officer and this relationship will be kept in confidence on my locked laptop. Those who wish to use the services of a Peace Officer who wishes anonymity will have to apply to me directly to use such services.

It is expected that SOME Peace Officers will want total anonymity as a guard against the Illuminati trying to find them. These Peace Officers will be issued identification and be given a specific number so that those who hire them can be sure the guy who turns up is from the MBA.

7.8. Travelling Without a “Driving License” Service

All around the world governments claim that men need a “driving license” to be able to drive a motor car. If you look into the history of the driving license you will find that it was first issued to men who were “driving” horses pulling wagons in commerce. Hhhmmmm. How do you drive a horse exactly?

The MBA will negotiate with governments that a “Driving Agreement” from the MBA is sufficient evidence that the man can drive a car safely and has agreed to full liability for any injury, harm, or loss he may incur. To get such a “Driving Agreement” the member will be required to complete an affidavit swearing that he is a competent driver, note details of his driving history and any accidents, and pledge all his worldly goods to remedy any accident that he may be the cause of. The MBA will then require that the associate make good for any injury, harm or loss accidentally caused.

The associate is perfectly welcome to take out an insurance policy to mitigate the risk should he so please. Up to him. What the MBA will do is negotiate with national governments that the MBA Driving Agreement will be honoured by their police and associates will not be harassed. If associates are harassed the MBA will prosecute the members of the government accountable and the Police Officers involved.

7.9. Document Registration and Retrieval Service

It was noted above in the Contracts Services that contracts will be able to be stored. There is more to it than that.

MBA will provide a Document Registration and Retrieval Service.

This service will be a case where associates can send valuable documents to the MBA. The following services will be provided:

1. Documents will be scanned in high resolution and placed on line where the client can retrieve them electronically and print them locally whenever so desired.
2. Certified copies will be produced on request for the appropriate fee.
3. Documents will be stored in a fire proof room in a fire proofed building as important documents.
4. Documents will be retrieved and resent to the MBA on request.

The main reason for providing this service is that it is common that men need access to their documents when travelling or, indeed, have forgotten or misplaced important documents. With this service there will never again be "misplaced documents". All important documents will always be available on line and certified copies can be sent to any location in the world in either hard or soft copy.

It is expected that the service will provide a number of levels of service which will include the ability to upload scans of documents for safe storage without the need for the physical paper. This would be extremely useful for men who have documents to store but do not need the extra service of the storage of the original document in the fire proofed building etc.

Such applications are now cheap enough to build and provide to the public that it makes sense to have such a business for the MBA.

It is expected that such services will be VERY interesting to MEN because when I was divorced my wife seized all important documents and placed them with "a friend". I was not able to retrieve such details as where my superannuation monies were kept etc. I still need to chase this up. She also seized my university degree, my birth certificate, the mortgage papers etc. It was a right pain in the arse.

If there was a service to place such important documents out of the wifes reach a LOT of men would take that.

Men would also have to have a will kept on file so as to whom to inform for next of kin etc should they die and MBA not be informed of the death.

7.10. Marketing And Business Development Services

The first core services that are being offered by a company that have become the first MBA are Web Site Development, Marketing and Branding Services.

These services are offered by a company called OPUS.

This includes all aspects of developing and hosting web sites, brand development, logo development, marketing program development and advice and guidance on how to get your business off the ground.

If you already have an existing business then OPUS can help you spruce up your existing web sites or create you a new one.

The Managing Director of the company, Phillip Butler, is a young man who is the son of a colleague of mine. My colleague has known the father for more than 20 years and can vouch for the lad being a good lad.

I have already put my own development work to OPUS in a small way and we will be getting OPUS to perform web site development for my own business purposes.

OPUS will also be the brand and web site developers for The Mens Business Association.

So far they are operating on normal commercial contracts and will do so for some time to come.

The entire infrastructure for MBA is not in place and men will not be able to migrate across to it until it is.

Until that time we will continue to operate in the normal commercial world.

When all the infrastructure is in place men can choose which parts of their business they might wish to migrate across to the MBA Business Environment.

I highly recommend OPUS to any man who wishes to get some professional help with branding their business.

Large or small they will be able to help you out. And because they are based in Cambodia the rates are far less than you would otherwise be required to pay.

7.11. Small Website Hosting

OPUS are a professional outfit that performs business for companies that want to take their product to market. There are smaller companies or individuals for whom OPUS is not appropriate as a provider of web sites. In these cases Instant Business Intelligence will provide webhosting services.

7.12. Other Anticipated Services

The range of services that MIGHT be provided in the future are very wide ranging. Pretty much ANY business will be able to be brought into the MBA and the men of the MBA benefit from the provision of that service. The services mentioned to date are the "Global Services" that are not tied to any particular country or location.

Of course, my own services as a Business Intelligence Consultant and the software I sell will be offered via MBA as well as via the normal corporate channels. The client will have the choice of which contracts they wish to sign up to.

Other anticipated services will include things like the following.

1. Software Development Services.
Because lots of men develop software.
2. Trades services.
Just imagine if all the men who are in the following trades joined MBA and refused to work under the jurisdiction of the "govement". Imagine if they all made oath to ALWAYS do the best job possible and if any claim by a client that they did not do their job correctly was fairly and justly adjudicated by the MBA to maintain the high standards of service. Imagine what might be possible then?

Perhaps each trade would form its own sub group and choose to test the men who apply to ensure their skills? Perhaps they would establish apprenticeships so that young men coming through can be trained to make sure they are up to scratch?

Perhaps when their name for quality and honesty is passed around they will get more business? After all, everyone knows how hard it is to find an honest mechanic.

- a. Builders
 - b. Bricklayers
 - c. Carpenters
 - d. Plumbers
 - e. Car Mechanics
 - f. Electricians
 - g. Painters, as in house painting
3. Professional Services
Just imagine if men in these professions were to join the MBA.
 - a. Teachers and lecturers.
 - b. Engineers.
 - c. Architects.
 - d. Chemists.
 - e. Doctors.
 - f. Natural Healing Practitioners.
 - g. Experts in Hydroponics....for growing food on the quarter acre block.
 - h. Professional Massage. (I have only just realised myself how good a professional massage really is for my body. It's well worth the cost!)
 4. Labourers Services
There is even a place for men who are laborers to get into the MBA. Lots of men need a man to come and labour for them for a period, often on a regular basis.
 - a. Lawn mowing and general house maintenance.
 - b. Home renovations such as putting in driveways or other heavier labour.
 - c. Movers to help moving houses. Those pianos need strong lads to lift them.
 - d. Eventually MBA members will be working on such things as road building, construction sites and the like because there will not be enough NON MBA members to do these things.

5. House Swapping for Holidays

I expect that MBA members would be interested in a service that does “house swapping” for holidays. This is big business in Sweden where so many people take time off over the summer. They rent their houses out on a weekly basis and can make quite a tidy sum for doing so.

6. Tour Guide Services.

MBAs who come from a local area could offer their services as tour guides to tell people of the local places from the perspective of the local and of a man. Too many tour guides are entirely superficial.

7. Language Translation Services.

Many MBAs will speak more than one language. They can offer their services in language translation. A client of mine wanted to translate a 50 page document from English into German and was quoted an exorbitant fee for doing this. I could personally use a good English to German translator that was affordable.

8. Relocation / Welcome to the Area Services.

One of the BIG services in London is relocation specialists. You don't have these much in the US. When people are coming into London they can hire a relocation specialist who will line up houses to go and look at and then help with the acquisition of the rented property.

A colleague of mine recently used one of these services to relocate to London. The guy lined up 12 houses to look at in 2 days. My friend got a great property to live in at a very reasonable price. The relocation agent picked them up from the airport, drove them around all day, and dropped them at the hotel each night. Then dropped them back to the airport.

My colleague RAVED over this service. It cost him about GBP2,000 for the entire service I believe. And remember. The agent had to chase down houses, go look at them himself first, cross off the ones that were no good, and STILL had 12 of them to show. My guess is the agent spent 2 or 3 days on the research and then the two full days with my colleague. So it would be likely pretty much one weeks work for the relocation. But since he would be relocating MANY people he would build up a contacts in the rental industry to be able to get the pick of the rental properties.

I have heard that NMA players complain they never get much help relocating to new cities. Now THERE is a lucrative market. Professional sportsmen relocating to a new city. Who would NOT want these guys as a client?

7.12.1. Coming Attractions

8. THE BENEFITS OF BEING AN ASSOCIATE

The benefits of being an associate are as follows:

1. Access to Documents.
You have access to all the documents and all the references to operate outside the jurisdiction of any governments should you so please. This is not an exclusive thing. If you use the book then you can interface to the public system and use it without being subject to the legislation of the governments.
2. Access to People and Experience.
You have access to people who have "been there and done that" and will share with you this valuable experience for a modest fee. If you think the price of education is high just look at the cost of ignorance.
3. Global Representation to Governments.
Most likely the most important aspect of this is that the MBA will issue documents to quite a large number of governments to rebut their presumptions that any MBA can be forced to be subject to the legislation of these governments.

The Associate can hire MBA members who will be very experienced with dealing with these governments to defend them from said Governments. These documents will be posted publicly on the MBA web site and Associates will be able to spread them widely to demonstrate the criminality of the governments.

Since we will have our own Peace Officers who will be able to lawfully act against members of governments it will be wise for those members of those governments to respond to us when we talk.

After all. We know who THEY are but they will not know who the Peace Officers are. They could be any man walking down the street. One of the BIG advantages of Peace Officers being totally anonymous is that that they can act without anyone knowing who they are. This is not going to be very popular with the criminals in the governments.

4. Access to a system of law for disputes.
Disputes are actually quite rare in a peaceful society. Crime is low when men do not need to steal to make ends meet. The MBA offers members access to a system of law that is open, transparent, fair and just, reliable and repeatable. Therefore, should any dispute arise a member can remedy that dispute without going to the existing "legal system" which is populated by criminals calls lawyers, magistrates and judges.

The cost of litigation today, or of getting a criminal matter sorted, is astronomical. When my wife stole EUR18,000 from our company account I was told it would cost a minimum of EUR50,000 to get that back. So all that could be done was ask for it politely. How insane is that? For my divorce? My lawyers fees in Dublin were EUR21,000 and in Australia AUD45,000. This is stupid money.

Members will be offered Peace Officers at the price set by the Peace Officer and Jury members for one ounce of silver per hour with the loser paying the costs of the jury trial. The Secretary of the MBA Court will be paid one ounce of silver per hour of service. The Expert in Common Law will be paid two ounces of silver per hour. Therefore a full days court time is likely to cost about 120 ounces of silver. Less if both parties agree to less than 12 Associates on the Jury.

5. Access to a system of contracts.
Creating contracts for businesses costs a LOT of time and money today. Every time you want a new contract created you go to a Lawyer to draft the contract for you. Every time you have to sign a new contract you have to read over it in detail and maybe get a lawyer to tell you if there are any loopholes in it. Contracts for the MBA will be simple and in plain English (and some may be localised for other countries) and will be binding on the member and the client.

A part of the contract will be to agree to the jurisdiction of the MBA Law Services for dispute resolution.

6. Support for the use of the World Passport

The World Passport, along with the world birth certificate and world identification card, are going to be the basis for identification and travel for MBAs. The MBA will support members travelling on these passports on a time and materials basis paid for by the associate. The MBA will do all it can to ensure that members are safe and not interfered with when travelling. However it is well understood that the goons at border patrol in many countries can be less than helpful.

The MBA web site will be a point of reference for the MBA to point the local customs officers to so that they customs officers are well aware of the fact that their government does NOT have jurisdiction over you. Naturally, if you are committing a crime then you won't be getting any assistance from the MBA. But if you are just travelling as is your right, we will assist as much as we can for a relatively nominal fee.

7. You Pay Lawful Taxes Only

The MBA will negotiate with the governments of the world to document what taxes they levy that are LAWFUL taxes. Any government that can not produce PROOF of a tax being LAWFUL will have notice served on them that they have no lawful right to levy that tax.

MBAs will only be required to pay lawful taxes where the governments have PROVEN the tax is lawful.

I get a lot of people who claim that not paying UNLAWFUL taxes is "somehow bad". Since when is not paying something that there is no lawful obligation to pay called "bad"? If OTHER people wish to pay UNLAWFUL taxes that is their right. I have nothing to say about them. I won't listen to what they have to say about me either. My position is simple. I pay ALL LAWFUL TAXES and I pay quite a few unlawful taxes where the collector of the taxes (usually shop keepers) are not aware that the tax is unlawful and will refuse to sell me the food I need to eat without paying the unlawful tax.

Such taxes as VAT are not lawful. Why should any man have to pay tax on the food he needs to eat and the water he needs to drink? That is the ultimate in tyranny. Since when does the government get to make money off basic human needs like food and water? What right is THAT of theirs to do that?

8. You are part of a global network

The MBA will grow to be a global network that will offer products and services to other members as well as to non members. The other members may promote your product and service and you may pay them commissions for doing so.

Members can promote other members products and services in the full knowledge that there is a system of law that will remedy any problems that the other member might cause. You can feel safe and secure in giving recommendations for members services even if you do not personally know the other member and even if you have not used their services.

This works BOTH ways.

You can recommend other members and other members can recommend you.

9. THE BENEFITS OF BEING A CLIENT/CUSTOMER

The benefits of being a client or customer are as follows:

1. Associates are under oath.
As a client of the Mens Business Association it is important for you to know all associates are under oath to act honestly with honour and integrity in all business dealings. The Mens Business Association is a “self policing” organisation and we take our brand very seriously. The founder, Joshua-Brandon: Boehm© will not tolerate crimes being committed by associates.
2. Associates are recommended by other associates.
To become an associate the associate is required to be recommended by two other associates who have known the applicant for a considerable period and make oath as to the applicants trust worthiness.

This requirement will be waived very early in the Associations life due to the lack of associates. Early in the associations life applicants will have to provide an affidavit from three men of good standing in the community as to their honesty and integrity.

3. Associates are rated by other associates.
We are all aware that some men are better at their jobs than other men. We also know that the BEST men to rate a mans skills, openly and honestly, are other men in the same profession. Our associates rate the skills of other associates. They do so openly and honestly so that clients can determine the relative skills of associates.

It is expected that the better the associate is at his job then the more money he will be able to ask for in his contracts. Those associates who honestly have less skill and less experience will be motivated to gain the skills and experience to gain the higher contract rates.

Further, by publishing skills and experience clients will be able to select the “right man for the job and budget”. If you have a simple home renovation to do then you can get it done by a “junior”. If you have a really hard home renovation to do then you get it done by a “master”. This applies across many business areas.

You, the client, are in control of who you hire and the skill level of the man you hire. We are building a fully transparent and open rating system for our Associates.

4. MBA Adjudication Services
You are guaranteed that you can make a claim to the MBA Adjudication Services for failure to live up to expectations of contracts and that your claim will be processed quickly at no cost to you unless the claim is frivolous. If the associate has met his contracted commitments you will be expected to pay the cost of the Adjudication Services as the complaint will be deemed to be frivolous.
5. MBA Law Services
You are guaranteed that you can bring a court case against the Associate should he have committed a crime against you. This will be at no cost to you unless you lose the court case. Should you lose the court case you will have to compensate the Associate for him time and trouble as well as the members of the jury, the expert in common law, the secretary of the court.

The cost of MBA Law Services is expected to be about 120 ounces of silver for a full days court proceeding. This is about the same cost as 10 hours of a lawyers time. That is, this is a very nominal amount. It is a very small price to pay for a lawful adjudication of the allegation of a crime.

6. MBA Peace Officer Services.
You are able to hire our Peace Officers to perform “Keeping the Peace” duties as and how you please. Our Peace Officers will be well versed on the work they can and can not do while being a member of the MBA. It is expected that clients will wish to use their service on an occasional basis as well.

10. THE COSTS OF BEING AN ASSOCIATE

The only cost of being an associate is the cost of application and the association fee per year.

The association fee per year is only payable should the applicant be accepted as an associate.

The association fee for early members will be waived as Joschua-Brandon: Boehm © will invest his own money to get the association off the ground.

After some period association fees are expected to be put in place. Those who get in early will not have fees for the first year. These fees are expected to be in the range of **EUR100 per annum.**

The way the fees will be calculated is that the base services that are required to be in place for all associates will be costed and divided among associates. The more associates there are the lower the annual fee. However, since the base services are so low the cost of the association fee is negligible compared to the income of the associate.

These base services will be the computer systems that are maintained and the web sites that are maintained to advertise the association itself. All such costs will be published to all members so they can see the actual costs of running the association.

All other services that the associate wishes to buy and consume will be paid for separately.

The association will run on a “user pays” system.

You want the MBA to get you a world passport? We will charge a fee for that. You can also choose to get it directly.

You want the MBA to keep copies of your world passport and your details on file so that we can represent you should you have a problem travelling? You will pay a fee for that. Should you actually use that service? You will pay a fee for that too.

It is a user pays system. **NO FREELoadERS.**

A computer system will be put in place such that users can exchange “money” between themselves and the association such that when an item is requested some “money” is exchanged between MBA and the associate.

We will have accounts in different “currencies” so as to stop the robbing of the banks and their “exchange rates”. We will also create a central account where the currencies are silver and gold and we will exchange credits of silver and gold for various work.

All services will be rated at a published cost in USD, Euros or ounces of silver for the foreseeable future. The currency for an offering will be that of the country in which it is offered.

The seller of the service carries the prerogative of how they wish to be paid for their service. It is expected that the currencies will be the national currency of the seller or one of USD, Euros Swiss Francs, silver, gold.

It is expected that the “money” system will run like www.enom.com where associates put money into the MBA as “credit” and then when the associate consumes a service that “credit” is transferred to the man who delivered the product or service. The man has the choice to drawn down on the credit or retain it for his own purposes.

If associates wish to pay each other via bank transfers and paypal and things like that? That is fine too. It is just that the banks take a slice of each transaction. By running a system of credits which are merely book keeping entries no transfer fees need to be paid. Just the maintenance of the underlying computer system.

11. THE OBLIGATIONS OF BEING AN ASSOCIATE

There are some obligations of being an associate.

1. You are obliged to pay a fee to be an associate.
This fee covers the costs of your membership on a direct cost basis. Nothing more. Costs of running the association will be published and the membership fee will be split to all associates.

For early associates it will be a fixed fee to get the association off the ground.

2. You are obliged to make oath to be an associate.
To become an associate you must make an oath. That oath is that you will, at all times, act honestly, with honour and integrity. You will not use fraud in your contracts. You will not cause injury, harm or loss to any other human being. You agree to the jurisdiction of MBA Law Services and, in the case of unresolved dispute, you agree to the jury trial.

You agree to the MBA Adjudication Services for disputes in contracts that are not alleged to be criminal.

3. You are obliged to jury service.
You are obliged to jury service as and when needed. There may be reasons why associates are exempted jury service but overall you will be required to sit on juries when there are allegations of crimes that are not resolved.

4. You are obliged to report any crime of any associate that you become aware of.
If you become aware that an associate is committing a crime and you do not bring this to the notice of the association then you are committing the crime of accessory to the crime. It may be before, during or after the fact. You will be subject to the same remedy as the criminal and you may ask for your own jury trial if you think that remedy is too harsh.

The MBA will be "self policing" in that members are expected to keep their eyes open for any other members who are "bending the rules". This is to keep the brand of the association as trust-WORTHY as possible.

We all know that most major corporates lie through their teeth when selling stuff. The people who buy these lies deserve all the problems they get. The MBA will be based on honesty, honour and integrity. Where men operate outside these parameters they will be dealt with most harshly and most publicly to make sure that our combined client base see that we take these things seriously.

5. You are obliged to disclose any work performed by any woman.
In the Mens Business Association only MEN can sign contracts and sign affidavits. This is because western women have claimed, and exercised, and defended, the right to commit perjury for some 30 years now. That they have done this is not refutable.

Women have decided that their oath is not worth the paper it is written on and therefore no contract signed by a woman will be subject to the MBA Law Services. If you, as an MBA, allow a woman to sign one of your contracts to become a client then you will have no protection from the MBA Law Services. Nor will you deserve it.

If you, as an MBA, choose to have a woman perform work that has been given to you by a client? Then YOU are still LAWFULLY responsible and accountable for that work. If the work is not up to scratch YOU will be the person facing the jury trial. NOT the woman.

If you employ women and if you advertise your services to the broader public then you must clearly articulate that you employ women.

If an MBA asks you for a guarantee that only men will perform work that is purchased from you then you have a choice to take that work or not. If you agree that only men will work on his work and then use a woman to do part of that work you are deemed to have committed contract fraud and the remedy will be severe as the crime is perjury under oath. You will have broken your oath to not use fraud in your contracts.

As an MBA you are under obligation to disclose any product or service you provide that provides income to a woman.

One of the reasons we are starting the Mens Business Association is that women have made the workplace very unsafe for men with all their false rape, false sexual harassment, false equal salary claims that many men simply wish not to be involved with women in the workplace. Those women who say "not all women are like that" have not spoken up and denounced the women who "are like that" and therefore must be similarly dismissed.

There is also the issue that women have petitioned the criminals in the governments to use taxes (paid by men in the vast majority) to give free money to women. Such things as low cost business loans for "women and minorities" are merely the women using the criminals in the government to steal from men.

Almost NO WOMEN have denounced such practices. They do not deserve for us to start companies and then hire them. If they are so "equal"? They can start "The Women's Business Association" and we will see them in the boardrooms in fair and just competition.

These are the ONLY obligations you choose to enter into when you join the Mens Business Association.

You are NOT obligated to get a world passport.

You are NOT obligated to consume or use ANY of the services offered.

You are truly free to choose what services you wish to consume or use.

Services will live and die based on the amount that men consume them or use them.

All billing for all MBA Base services will be completely open and transparent to members.

Members have the right to query any bill and have it explained to them.

How members manage their contracts with each other or with clients is up to them.
